

# **Transparency and Openness (TOP) Guidelines - TOP 2015**

Citation Standards Describes citation of data	Data Transparency Describes availability and sharing of data
Analytical Methods Transparency Describes analytical code accessibility	Research Materials Transparency Describes research materials accessibility
Design and Analysis Transparency Sets standards for research design disclosures	Preregistration of Studies Specification of study details before data collection
Preregistration of Analysis Plans Specification of analytical details before data collection	Replication Encourages publication of replication studies

- the final research output must disclose if the work satisfies the standard
- 2 REQUIREMENT: the final research output must satisfy the standard
- 3 VERIFICATION: third party must verify that the standard is being met

## **Factors Motivating TOP 2025 Changes**


- Inconsistent levels across standards
- Dependencies across standards
- Lack of applicability for some practices to some methods
- Poor reliability of scoring suggesting lack of clarity for some standards

### **Three Major Classes of Revisions**

- 1. Revisions to research practices
- 2. Consistent levels for research practices
  - Disclose, Share and Cite, Certify
- 3. Reorganized structure for TOP with three categories of standards
  - Research practices, verification practices, verification studies

## Three Levels of Stringency







#### **DISCLOSE**

Researchers must state whether or not a practice was done and, if so, its location.


#### **SHARE & CITE**

Researchers
must share the
output and cite
its location in a
trusted
repository.

#### **CERTIFY**

Independent party certifies that a practice is done to disciplinary best practice standards.









